The Ministry of Sports and Social Welfare, Sports and Social Welfare Division, Strengthening Systems to Protect and Uplift Women Project, Project Implementation Unit (PIU-1), Jhanakpurdham, Dhanusha ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of Construction of Rehabilitation Centre at Madhesh Province, Lalbandhi, Sharlahi ("the Works").
3. Open competitive bidding will be conducted in accordance with ADB's Single-Stage: Two-Envelope (1S2E) procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
 - a) Average Annual Construction Turnover (as per section 3 of Bidding Document): NPR 198.5 million.
 - b) Financial Resources (as per section 3 of Bidding Document): NPR 33 million.
 - c) Contracts of Similar Size and Nature (as per section 3 of Bidding Document): NPR 131.5 million (including VAT).
 - d) Bid security (as per section 2 of Bidding Document): NPR. 3.3 million.


