5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2026/06/01 on 14:00** at the office of **Ministry of Sports and Social Welfare, Janakpurdham**.
6. Bids must be valid for a period of **90 Days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **2,55,000/-**, which shall be valid for 30 days beyond the validity period of the bid 2026/09/29. If the Bidder wishes to submit the Bid Security in the form of cash deposite the amount in following, and submit the receipt of the deposited amount of cash along with the bid.
